 EARLIER IN THE EVENING SHE AND MR. MELTON HAD BEEN IN DISAGREEMENT

ABOUT A NUMBER OF THINGS, BUT PRIMARILY THEY DISAGREED ON HOW MR. MELTON WANTED MS. [REDACTED] TO LOOK. ACCORDING TO MS. [REDACTED], MR. MELTON BROUGHT OVER A MAGAZINE WITH WOMEN THAT FIT THE IMAGE HE HAD IN MIND FOR MS. [REDACTED]. AT THIS POINT IT WAS A VERBAL DISAGREEMENT AND MR. MELTON LEFT WITH MS. [REDACTED]'S CAR KEYS TO GO GET A VIDEO FOR THE EVENING. MS. [REDACTED] THEN CALLED MR. MELTON AT HIS ROOM [REDACTED] AND ASKED THAT HE BRING THE KEYS BACK TO HER AND THAT SHE DID NOT WANT TO WATCH A VIDEO WITH HIM. MR. MELTON THEN WENT TO THE VIDEO STORE BEFORE RETURNING THE KEYS. ACCORDING TO MS. [REDACTED] WHEN MR. MELTON ARRIVED AT HER DOOR, HE BEGAN POUNDING ON THE DOOR YELLING AT HER. HE THEN OPENED THE DOOR WITH THE KEYS AND ENTERED THE APARTMENT. MS. [REDACTED] THEN TOOK THE KEYS FROM MR. MELTON AND ASKED HIM TO LEAVE THE APARTMENT. MR. MELTON CONTINUED YELLING AT MS. [REDACTED], CALLING HER A FUCKING WHORE. MS. [REDACTED] WAS YELLING BACK AT MR. MELTON ASKING HIM TO GET OUT. ACCORDING TO MS. [REDACTED], MR. MELTON THEN GRABBED HER AROUND HER THROAT. MS. [REDACTED] FOUGHT HER WAY OUT AND TRIED TO FEND MR. MELTON OFF BUT HE GRABBED HER BY THE WRISTS AND FORCED HER DOWN UPON A COUCH IN THE APARTMENT.

I, OFC. CAST, COULD NOT FIND ANY MARKS, BRUISES, OR INDICATIONS THAT SUCH ACTIONS HAD OCCURRED UPON MS. [REDACTED]. MS. [REDACTED] WAS OBVIOUSLY DISTRAUGHT BY WHAT HAD OCCURRED BUT WAS RELUCTANT TO SPEAK WITH ME. SHE TOLD ME THAT THE POLICE COULD NOT DO ANYTHING FOR HER, SO WHY SHOULD SHE SPEAK WITH ME. IT WAS ONLY AFTER EXPLAINING DOMESTIC VIOLENCE TO MS. [REDACTED] THAT SHE BEGAN TO OPEN UP AND SPEAK FREELY. I THEN SPOKE WITH JAYME HOLLIGAN WHO RESIDES IN APT [REDACTED] AND IS SUITE MATES WITH MS. [REDACTED]. MS. HOLLIGAN TOLD ME THAT MR. MELTON HAD BEEN PHYSICALLY AND VERBALLY ABUSIVE IN THE PAST. MS. HOLLIGAN STATED THAT SHE HAS HEARD HIM HIT HER IN THE PAST, BUT THAT MS. [REDACTED] HAD ASKED HER NOT TO SAY ANYTHING. ACCORDING TO MS. HOLLIGAN, SHE COULD RECALL AT LEAST THREE TO FIVE PRIOR EPISODES. I THEN SPOKE WITH A WITNESS FROM APT # [REDACTED], MS. ANNA PETERS. SHE WAS THE REPORTING PARTY TO OUR DISPATCH CENTER AND STATED THE FOLLOWING: SHE HEARD MR. MELTON, WHO SHE IS FAMILIAR WITH, FROM PRIOR ARGUING AT APT. [REDACTED]. MS. PETERS HEARD MR. MELTON KICKING THE DOOR AND SLAMMING THE DOOR, FOLLOWED BY VERBAL ARGUING AND THE SOUNDS OF FOUR TO FIVE SLAPS SKIN UPON SKIN. MS. PETERS HEARD MS. [REDACTED] ASK MR. MELTON TO LEAVE AND MR. MELTON SAY TO HER "...YOU FUCKING WHORE..." FOLLOWED BY WRESTLING SOUNDS AND MS. [REDACTED] YELLING, "LET GO OF MY NECK" AND "GET OFF OF ME." MS. PETERS STAYED ON THE PHONE WITH DISPATCHERS UNTILL OUR ARRIVAL. MS. [REDACTED] DURING OUR CONVERSATION RELAYED THE FOLLOWING TO ME: IN JUNE OF 1999, SHE AND MR. MELTON HAD AN ARGUMENT SIMILAR TO THE ONE TONIGHT, BUT IN THIS CASE HE KNOCKED HE DOWN HARD ENOUGH TO BREAK HER TAILBONE. SHE TOLD ME THAT SHE HAD IT X-RAYED BY STAFF AT C.U.'S WARDENBERG MEDICAL CENTER AND IS DUE FOR A MRI WEDSDAY WITH THE POSSIBILITY OF SURGERY BECAUSE OF THE INJURY TO FUSE THE BONES TOGETHER. MS. [REDACTED] TOLD ME THAT HE HAS BEEN VIOLENT SINCE THEY BEGAN SEEING EACH OTHER ONE AND A HALF YEARS AGO. THAT HE HAS PHYSICALLY AND VERBALLY ABUSED HER ON A WEEKLY BASIS. MS. [REDACTED] TOLD ME THAT SHE WOULD LIKE TO END THE RELATIONSHIP BUT WAS UNSURE HOW. I ARRESTED MR. MELTON FOR THIRD DEGREE CRIMINAL TRESPASS AND HARASSMENT DOMESTIC VIOLENCE.

I ASKED MS. [REDACTED] IF SHE WOULD LIKE TO SPEAK WITH A [REDACTED] ADVOCATE AND SHE STATED THAT SHE WOULD. I CONTACTED "AMIEE" OF THE BOULDER COUNTY [REDACTED] WHO TOLD ME THAT MS. [REDACTED] ASKED HER COME OVER AND TALK TONIGHT I ALSO LEFT MS. [REDACTED] WITH A VICTIMS RIGHT BOOKLET AND A BUSINESS CARD WITH THE CASE NUMBER UPON IT.
