# APPROVING THE PROFESSIONAL SERVICES AGREEMENT BETWEEN LOGAN SIMPSON DESIGNS, INC., AND PUEBLO COUNTY FOR A NEEDS ASSESSMENT AND MASTER PLAN FOR THE DOWNTOWN YOUTH SPORTS COMPLEX

**WHEREAS,** at the 2016 November Election, the voters approved County Ballot Issue No. 1A that committed revenues from expiring Tax Incentive Agreements to community improvement projects such as the Downtown Youth Sports Complex project; and

**WHEREAS**, this Board desires to obtain professional consulting services to prepare a Needs Assessment and Master Plan for the Runyon Youth Sports Complex located at 400 Stanton Ave., Pueblo, Colorado 81003; and

WHEREAS, the Pueblo County Purchasing Department sought and received proposals by RFP NO. 20-13: Professional Consulting Services for the Needs Assessment and Master Planning for the Downtown Youth Sports Complex Project. Logan Simpson Designs, Inc. submitted the best proposal and the Pueblo County Project 1A Project Manager recommends that the Board of County Commissioners enter into a Professional Services Agreement with Logan Simpson Designs, Inc.; and

**WHEREAS**, this Board concurs with the aforementioned recommendation and desires to enter into a Professional Services Agreement with Logan Simpson Designs, Inc., for the Needs Assessment and Master Plan for the Downtown Youth Sports Complex Project at the Runyon Youth Sports Complex located 400 Stanton Ave., Pueblo, Colorado, subject to the appropriation of funds for this project.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Pueblo County, Colorado, that the Agreement between Logan Simpson Designs, Inc., and Pueblo County for the Needs Assessment and Master Plan for the Downtown Youth Sports Complex Project at the Runyon Sports Complex located 400 Stanton Ave., Pueblo, Colorado, the terms and conditions of which are incorporated herein by this reference, is hereby approved and the Chair of the Board of County Commissioners is hereby authorized to execute the same on behalf of Pueblo County.

# SUPPORTING A COUNTYWIDE VARIANCE PROTECTION PROGRAM AND REQUESTING APPROVAL THEREOF BY COLORADO DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT AND GOVERNOR JARED POLIS

WHEREAS, on November 19, 2020, the Colorado Department of Public Health and Environment ("CDPHE") sent a letter to Pueblo County ("County") informing the County that it would be moved on the COVID-19 Dial Level from Orange to Red commencing at 5:00pm on November 22, 2020. The County permanently lost its sector variance from certain public health order restrictions when it was moved to Level Orange on November 14, 2020; and

WHEREAS, COVID-19 Dial Level Red ("Level Red") requires the County to implement further restrictions across many sectors as described in Section II. F. of CDPHE's Public Health Order No. 20-36, as amended. Significantly, such restrictions include, but are not limited to, the closure of bars, the prohibition on indoor dining and the reduction of gym capacity to 10% of the facility's capacity; and

**WHEREAS,** the severe restrictions imposed by Level Red has been devastating to numerous small businesses in Pueblo County, many of which have strictly followed the COVID-19 protocols to operate safely; and

WHEREAS, while the Pueblo Board of County Commissioners ("BOCC") endorses CDPHE's orders disallowing businesses from operating in an unsafe manner during the pandemic, the BOCC believes to further restrict or close down businesses that have a proven track record of complying with the health and safety protocols required by federal, state and local public health authorities where there is no evidence that virus transmission is coming from these business does not further the goal of restricting growth of virus transmission in Pueblo County; and

WHEREAS, the BOCC recognizes the plight of small businesses during the pandemic and has committed \$1.5 million of its CARES funding allocation to provide economic relief grants to small businesses and non-profit organizations However, even with financial assistance from Pueblo County and other governmental organizations and entities, many small businesses in our community still face the looming possibility of permanent closures and loss of livelihoods; and

**WHEREAS**. Mesa County has developed a Variance Protection Program, also referred to as the 5 Star Certification Program, that allows qualifying businesses who demonstrate a commitment to following certain health and safety protocols to operate at 50% of capacity, which may be allowed as an exception to the Level Red restrictions pending the State's review; and

**WHEREAS**, the BOCC desires to develop and implement a similar variance protection program countywide as soon as practicable to allow responsible small businesses to continue to operate in a capacity that will allow them to maintain their livelihoods while the County is on Level Red of the COVIDO-19 Dial; and

**WHEREAS**, Pueblo County is committed to working with the City of Pueblo and the Pueblo Department of Public Health and Environment to develop a meaningful plan to allow the owners and employees of conscientious businesses that are suffering due to the shutdown to continue to operate under less restrictive rules and desires to submit that plan to the Governor and CDPHE for approval; and

WHEREAS, the BOCC respectfully requests the Governor and CDPHE to consider and approve

Pueblo County's variance protection program proposal that will bedeveloped pursuant to this Resolution.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of County Commissioners of Pueblo County, Colorado hereby directs its staff to work with the City of Pueblo and the Pueblo Department of Public Health and Environment forthwith to develop a variance protection program for Pueblo County that would allow qualifying small businesses to continue to operate while maintaining public safety during the period Pueblo County is placed under Level Red of the COVID-19 Dial.

**BE IT FURTHER RESOLVED** by the Board of County Commissioners of Pueblo County, Colorado that upon its finalization said variance protection program proposal shall be submitted to Governor Jared Polis and the Colorado Department of Public Health and Department for consideration.
